









New Wellness Plan for 2022

This coming year you have new options to be eligible to receive the 2023 medical deduction premium discount of 20% under the Ricoh's improved wellness program.

You need to complete **2 Gateway activities** and earn at least <u>1300 points</u>. Activities completed between **September I, 2021 and August 31, 2022 will qualify**.

Start by completing the Gateway Activities*:

Employees who previously completed the Gateway activities or registered for Teladoc with Meritain will receive credit automatically. Employees may receive duplicate credit on several items due to the shift in program dates (Sept 2021 overlap). This is to give credit for 2022 open enrollment and is not intended to continue in the future once program dates are realigned.



Completing the Challenges means...not only do you earn points towards your medical premium discount and work on your personal wellness goals, but you also earn an **EXTRA REWARD** opportunity!!!!!

Three times during 2022, a raffle will be held (April – July – September)

Thousands of dollars will be up for grabs for those who go the extra mile. All employees with active employee status on the date of the raffle and who have completed their two Gateway activities and earned at least 750 points by the last day of the month prior to the raffle, will be entered into the raffle. Multiple winners will be selected for each raffle drawing and winners will receive a gift card valued between \$50-\$1,000, depending upon the number of points earned. Winners of the first raffle, can still win again on the 2nd or 3rd raffle! Winners will receive credits based on the number of points they have earned in the Wellness Challenges. Gift cards are subject to taxation and added to W-2 income.

We can all do this! There are many combinations of activities you can do to earn the needed points for the premium deduction credits plus earn extra rewards. The sooner you get started the more chances you have to win. Employees who complete the Age Gage-Health Assessment, Healthy U Online Courses, and Preventive Medical, Dental and Vision exams will earn over the 2000 points, qualifying them for the 20% discount, plus a raffle entry to win \$200. Employees who do everything except the last two challenges will earn 3,500 points, earning the 20% discount plus a raffle entry to win \$1,000 worth of gift cards.

How will it work? All employees who completed the Gateway activities and earning 800 points by 11:59 pm on March 31st, will be eligible to participate in the April raffle to receive \$50 worth of gift cards. When the gift card is provided, it will be considered taxable income and reported to payroll. It will appear on the paycheck as soon as administratively possible.
